Matagami, July 8, 2020 – The Québec cabinet appointed Mr. Jonathan Lapointe to the SDBJ Board of Directors on June 10, 2020.

Mr. Lapointe graduated from Université Laval with a Bachelor of Science degree in Metallurgy and Materials in 2003 and has been a member of the Ordre des ingénieurs du Québec since 2006.

He began his career in the mining industry in 2003 as a process control and production metallurgist for the Inmet Mining Corporation. He then held the position of Chief Metallurgist and Concentrator Superintendent at Campbell Resources Inc. from 2006 to 2009. As a parallel venture in 2007, he founded Metchib Metallurgical Services Inc., a company specializing in laboratory mineral processing and metallurgical demonstration plant installations, where emphasis is placed on research and development with a view to creating new business opportunities in the region. In 2015, Mr. Lapointe became Founder and Vice-President of Business Development at Minopro Inc., as well as Founder and Vice-President of Training and Operations for Minopro-Cree Resources Inc.
